TRG Committee's Report 2022/2023 (from 21st June 2022 till 7th June 2023)

2.1 Planning Applications

During this period, TRG has engaged principally in making submissions for applications/appeals outside the Triangle that would have had a negative

impact here. These were principally in relation to 85 Queens Road (The old Café Rouge site) and applications in South Road.

A significant and somewhat controversial application was lodged in respect of No 6 Pine Grove but was subsequently withdrawn. A revised proposal has been submitted with a closing date of 9th June 2023.

A notable feature in terms of how planning applications are considered, both at the Elmbridge and Planning Inspectorate levels, continues to be the willingness to consider insufficient off -street parking provision under DM7 and resultant parking stress as a legitimate reason for refusal.

2.2 Elmbridge consultation on community involvement in planning applications and Local Plan consultation.

TRG submitted its response to the following two Elmbridge proposals:

- to stop publishing representation letters for planning

applications on the Council's website

- to cease delivering hard copies of the Local Plan

consultation documents to all public libraries

TRG disagreed with both proposals. Its response can be seen <u>here</u>.

2.3 Traffic and Parking

At a meeting between TRG representatives and Surrey CHA team on 21st March 2022, TRG conveyed residents' concerns, and the Surrey CC team undertook to consider the points made, carry out further studies and revert. We were initially advised that the Triangle would be rolled into the Atkins Study, examining road flows through Weybridge, then that it would be considered separately but in a related study.

TRG has since sent 4 reminders. We have yet to receive anything other than a holding response but will continue to press.

2.4 Newsletters

8 newsletters have been published since the last AGM.

2.5 Finances

TRG is funded entirely by donations, whether from Committee Members or residents. These defray website and any printing costs incurred. Any funds we have are held on our behalf by Ferdi Fischer. We currently have a credit balance of £40, which is held by Ferdi Fischer.
